

Peace Terrace Academy - Financial Aid Application for 2018-2019



Dear Parents, Assalam-u-Alaikum WA Rahmatu Allah WA Barakatuhu!

Peace Terrace Academy offers financial aid to students who demonstrate academic excellence and whose families display a legitimate financial need. The Academy has a limited amount of resources and only part of it can be dedicated towards financial aid for deserving students. Therefore, a very strict criterion to determine a family's eligibility is used and examined throughout the academic year. The following eligibility criteria shall be used, but not limited to, for accepting the application:

- A family's financial condition
- A student's academic standing (merit based selection)
- A student's attendance and conduct at Peace Terrace Academy (for continuing students)

Parents who are not able to meet the financial obligations of Peace Terrace Academy above and beyond any outside scholarship sources (i.e., BASIC Fund, www.basicfund.org) may be eligible for additional financial aid through the school.

To apply for PTA Financial Aid, please complete the following requirements:

- 1) Submit a complete Financial Aid Application no later than June 1st 2018. Please make sure that you fill out the entire application completely and accurately. Incomplete applications will not be processed.
- 2) Submit a copy of your 2017 income tax return, all W2s, and 1099s. This information will only be used for validation purposes. Once the decision is made, all submitted documents will be destroyed. Please make sure you submit **photocopies** of all the required documents.
- 3) Submit a copy of your bank statements for all bank accounts under your name or the name of your business, if any, for the past 12 months. Please make sure you submit **photocopies** of all the required documents
- 4) Copy of the last report card and standardized test results. Your child might be assessed, if deemed necessary, after the review of a previous report card and standardized test results.
- 5) If you have been approved through BASIC fund, submit a letter of determination from the BASIC fund. Please refer to www.basicfund.org. If an attempt is not made on your part to apply for BASIC fund by their deadlines, your PTA Financial Aid Application will not be considered.

The final determination for financial aid will be made no earlier than June 31, 2018 for the first reviewing period after an interview with the selection committee.

PTA might utilize the funds to cover the tuition from the Zakat fund also. Please indicate in your application if you do not wish to accept Zakat.

Who is entitled to receive Zakat? (Please note that this is for reference only. You should speak with a scholar who is trained in this area as there may be a difference of opinion.)

There are eight groups of people on whom Zakat should be spent, as mentioned in the Quran: "The alms are only for the Fuqara' (the poor), and Al-Masakin (the needy) and those employed to collect (the funds); and to attract the hearts of those who have been inclined (towards Islam); and to free the captives; and for those in debt; and for Allah's Cause, and for the wayfarer (a traveler who is cut off from everything); a duty imposed by Allah. And Allah is All-Knower, All-Wise." [Al-Quran 9:60]

*Fuqaraa: Those who own property in excess of basic necessities but below the value of Nisab.

*Masakeen: Persons of extreme poverty who possess no wealth whatsoever.

*Aamileen: (Zakat collector) those persons who are appointed by an Islamic Head of State or Government to collect Zakat. It is not necessary that this be a needy person.

*Muallafatul Quloob: Those poor and needy persons who are given Zakat with the intentions of solidifying their hearts because they maybe recently converted to Islam or to bring them closer to Islam.

*Ar-Riqaab: slaves whose masters have agreed to set them free on a payment of a fixed amount. Zakat may be used to purchase their freedom. (Not Applicable)

*Ibnus-Sabeel: A traveler, who, whilst wealthy at his residence, is stranded and in need of financial assistance.

*Al Ghaarimeen: A person whose debt exceeds his assets and his net assets (after deducting his liabilities) is below the Nisab limit. To determine whether a person qualifies, his basic necessities of life (house, furniture, clothes, vehicle, etc.) will not be taken into account. It is conditional that the debts were not created for any un-Islamic or sinful purpose.

*Fi Sabeelillah: Those who are away from home in the path of Allah. Those in Jihad, those seeking knowledge or a stranded Haji may be assist with Zakat if they are in need.

Zakah Eligibility Criteria:

The nisab (i.e. amount above which the applicant does not qualify for zakah) is the value equivalent to 85 grams of gold or 595 grams of silver of unused net asset value over the past lunar year. Eligibility of Zakah is tagged to the family assets, not income. Assets used for personal use like primary residences, jewelry for women and cars are excluded. Liabilities (debts), penalties and taxes associated with assets listed below should be deducted from their gross asset value.

2) To qualify for Zakah, the following four net asset values that you had for more than a lunar value should add up to be less than the Nisab:

- a) Any savings such as cash, bank accounts, gold not used for jewelry, etc.
- b) Pension plans, 401k, IRA, children's savings, etc. Subtract the 10% pre-payment penalty and taxes you would incur from early withdrawal.
- c) Value of any owned property other than your primary residence. This includes second house/complex, land, assets, etc.
- d) Value of stock or stock options minus the exercise price and taxes you would owe.

Policies:

- Financial aid is not issued for PK and Pre School
- Financial aid applies only to US citizens or permanent residents
- Meeting the deadlines is an important part of the financial aid process. Delays may result in reduced availability of funds and/or lower financial aid award.
- Determination for the approval of the financial aid might take longer; it is the responsibility of the parents/guardians to fulfill the regular obligation of the tuition until it has been approved. If no financial aid (or partial aid) is granted, it is the responsibility of the family of the student to undertake full payment of the tuition and other financial obligations as outlined in the Financial Agreement for the current school year.
- Incomplete applications will not be considered for financial aid.
- Submission of this application does not guarantee any financial aid. The PTA School Committee will determine the eligibility and the amount to be granted, if any, based on the criteria set for the purpose.
- Minimum payment per student after award is 20% of the tuition.
- Financial Aid does not cover any fees or costs besides the tuition.
- Continuing students get priority. (Continuing students are those who have completed at least a year in PTA)
- Submission of the application does not entail any obligation of acceptance on part of the school. If you are denied for financial aid and you are not able to meet the financial obligations of Peace Terrace Academy, your child will not be admitted into class. Make sure that you have a backup plan by having your child enrolled in another institution.
- School will only administer the assessment (if deemed necessary) after the initial registration has been completed. Your child must pass in order to be considered for financial aid. If your child is not able to pass the test, you must be willing to enroll your child into a lower grade for which he/she is able to pass this test
- All scholarships are considered part of your financial aid package and must be reported with the application. PTA requires that all financial resources available to the student must be taken into account when making a determination.
- In case of Zakat/Sponsorship Recipients, student's academic information might be exchanged if requested by the sponsor to ensure the success of the students.
